Thank you for circulating the draft Rules of Procedure relating to the Interparliamentary Conference on Economic and Financial Governance ("IC-EFG"). As the representatives of the House of Commons and House of Lords attending the inaugural conference in Vilnius on 16-18 October, we are writing to you to provide comments on these draft Rules, as requested.

In general, we strongly support establishing Rules of Procedure for the IC-EFG, which we believe will assist in facilitating the work and efficiency of the Conference within the framework envisaged by Speakers which was agreed in Nicosia in April. In this context, we note the letter of the European Parliament President, Martin Schulz, of 8 October in which he states the opposition of the European Parliament to agreeing Rules of Procedure in Vilnius. We do not believe that the principle of having Rules of Procedure is inconsistent with the agreement reached by Speakers in Nicosia, and we would welcome our European Parliament colleagues elaborating on any concerns they have when we meet next week.

Turning specifically to the draft Rules circulated, we welcome Article 1.2, which indicates that the IC-EFG will replace the relevant meetings of chairpersons and the European Parliamentary Week of the European Semester. Such streamlining will help to avoid duplication and to keep the IC-EFG as cost-effective as possible, and it would be in keeping with the spirit of the agreement reached by Speakers.

Regarding the conduct of the meetings (Article 3.4), we would suggest that the wording of this could be supplemented to indicate that determining the "relevant committee(s)" and chairperson(s) or their designated deputies is a matter for individual Parliaments. This would reflect the provision in Article 4.1 that the composition of delegations is a matter for each Parliament, in accordance with its own organisation and structures for scrutiny.

We also welcome the encouragement of side events in Article 3.6. It has been our experience at other conferences that working groups and break-out sessions can encourage debate and allow parliamentarians to focus in on specific and detailed areas of interest. However, it is important that

such side events should be open to all participants, and the wording of this Article should be revised to reflect this.

Finally, we would question the value of majority voting (Article 3.7) at the IC-EFG. We are of the view that consensus decision-making, as employed at the CFSP/CSDP conference, would be the more appropriate method, both in the context of any Conclusions of the conference and future revisions to the Rule of Procedure. A consensual approach would also be in keeping with the spirit of the agreement reached by Speakers and reflect what we hope will be the IC-EFG's focus on debate and the exchange of information and best practice.

In consideration of the above points, we attach a list of proposed amendments from the UK delegation.

We look forward to a successful conference in Vilnius later in the month and to discussing the substantive policy issues related to economic and financial governance within the EU. We are disappointed that the debate on the draft Rules that had been scheduled in the draft programme has subsequently been removed, and hope that it can be reinstated. It is important that, in the spirit of interparliamentary cooperation, there is time for a debate on the draft Rules - which does not have to be lengthy - where delegations are given the opportunity to express their views.
